



### **MEMORANDUM OF UNDERSTANDING**

Between Tashkent Institute of Irrigation and Agricultural Mechanization Engineers (Tashkent, Uzbekistan) and Cracow University of Technology (Cracow, Poland), hereinafter referred to as the Parties, desiring to develop bilateral cooperation in the field of higher education, recognizing the fruitful and mutually beneficial cooperation, agreed on the following:

### **Article 1**

Parties on the basis of equality and mutual interest, in accordance with the national legislation of their states and, within its competence will develop bilateral cooperation in the following forms:

- 1. Exchange of teachers and other staff, as well as students for collaborative learning;
- 2. The establishment of joint undergraduate and master programs on double degree diplomas and joint doctoral programs and co-tutoring;
  - 3. Development and application of joint national and international research projects;
- 4. Using digital and Web resources for joint educational programs ("distance learning" and "e-conference");
- 5. Promote and facilitate the involvement of qualified students in joint academic programs;
  - 6. Development of short and long term training courses;
  - 7. Promote joint academic publications.

#### Article 2

- 1. In order to implement this Memorandum, the Parties, if necessary, by mutual agreement can constitute individual plans or programs for its implementation in the field of graduate and post graduate education.
- 2. Before performing any activities, the Parties should develop an agreement based on mutually agreed tasks and expected results;

3. The Parties agree to promote cooperation to encourage exchanges during sabbatical leaves, trainings, visits by teachers, study of students and other educational and research activities.

## Article 3

This Memorandum does not impose on the Parties any legal and financial obligations.

### **Article 4**

In case of disagreement at interpretation or application of the provisions of this Memorandum, the Parties shall settle them through consultations and negotiations.

# Article 5

By mutual consent of the Parties to this Memorandum may be amended and supplemented, are separate protocols, which form an integral part of this memorandum.

### **Article 6**

The parties may terminate participation in this Memorandum at any time by giving written notice of its intention six months before the intended date of withdrawal.

Termination of this Memorandum shall not affect the implementation of ongoing projects or programs that have been launched in the framework of this Memorandum, unless the parties otherwise agree.

This Memorandum should enter into force on the date of signature.
